Skin diseases should always be considered as a common disease of all organism. In turn, skin diseases can provide a sharp and deep effects on the whole body. The reasons can be divided into external and internal.

*The following should be considered external:* 

1. Infectious (bacteria, viruses, etc.), including parasitic (protozoa, helminths, arthropods, etc.)

2. Caused by exogenous (external) factors - chemical, physical;

3. Caused by endogenous (internal) factors – disorders metabolism, disorders of the endocrine or nervous systems;

4. Impaired skin development.

Internal causes of skin diseases can be:

1. Metabolic disorders. An example is the deposition of salts in the skin when gout, cholesterol in disorders of lipoid metabolism;

2. Dysfunction of the endocrine glands that cause seborrhea, common acne, sometimes diabetes;

3. Diseases of the internal organs. Skin diseases are not uncommon develop in people with worm diseases, liver disease, stomach, etc .;

4. The state of beriberi;

5. Consumption of certain foods, such as chocolate;

6. Allergic conditions, ie hypersensitivity of the skin to certain substances-allergens, such as foods (eggs, crayfish, strawberries) or chemicals substances (paints, resins).

Local treatment of skin diseases. Local or external treatment of skin diseases is of great importance. His the goal is to accelerate the healing of existing foci and eliminate or reduce unpleasant ones itching, burning, etc. In the local treatment of skin diseases are most often used as follows medicines: powders, lotions, lubrication with wet bandages, pastes. Oils, ointments, compresses, plasters.

Proper drug technology is important for successful treatment. It is necessary to dose the drugs correctly, follow the schedule of their use and not to be engaged self-medication physiotherapy of skin diseases.

Widely used treatment of skin diseases with heat and cold. To thermal treatments include baths, grills, Solux lamps, blue Minina lamp, applications of paraffin and ozokerite.

Cold treatment is used for edema. Cold is prescribed in the formlotion. A special type of treatment is the freezing of hard coal acid - cryotherapy. From a source of radiant energy often involved ultraviolet rays from quartz lamps.

**Conclusion**. Skin - the natural covering of the human body, the boundaries between themselves and the environment. The skin performs the functions of protecting organism from adverse environmental influences. Skin diseases should always be considered as general disease of the whole organism.
