## MEDICAL PRESCRIPTION COMPLEX ASSESSMENT OF NARCOTIC AND PSYCHOTROPIC DRUGS

Narcotics, psychotropic drugs are substances of natural and synthetic origin that are dangerous to human health and the condition can cause dependence.

These funds are subject to control by CMU from 05.06.2000 № 770 (as amended). Unfortunately, today in Ukraine, the business of pharmacy comes to the fore. Doctors rarely prescribe recipes.

Pharmacists receive a list of drugs prescribed by your doctor, not on the prescription forms and letters on paper [1,2].

**The aim** is a medical prescription complex assessment of narcotic and psychotropic drugs.

**Research methods.** The paper used field research, a questionnaire sacrament of physicians (15%) and utilities (85%) of health care institutions.

Respondents doctors with different specializations: general practitioners (70%), neurologists (15%), psychiatrist (5%), gynecologist oncologist (5%), surgeon (5%).

**Results.** During the study found that 65% of physicians in the appointment prefer imported drugs.

Asked about the factors limiting the availability of narcotic and psychotropic drugs, all the doctors said that the limitations dictated: the specificity of these drugs (legal restrictions, the possibility of addiction), lack of prescription forms, the high cost of drugs. Treatment of these funds is restricted in all countries. All doctors try to prescribe fewer drugs and psychotropic drugs.

All appointments take place in specialized departments (surgery, oncology, psychiatry), where the tough reporting on purpose, storage and use, both of

narcotic drugs and prescription forms. In terms of doctors, patients sometimes can not buy them the necessary medication. And this, in their opinion, is due to several factors: the absence of drug in the pharmacy (25%), no prescription (30%), the high price of the drug (20%), lack of desire to be treated (17%) and others.

When searching for information on medicines practitioners use different sources. All the doctors said that the most relevant information they receive from communication with the medical representatives of leading manufacturers of drugs (medical conference, collection of scientific articles, analysis of experience taking new drugs, new methods of treatment).

## Conclusions.

- 1. Medical prescription complex assessment of narcotic and psychotropic drugs has been studied.
- 2. Revealed that the availability of narcotic and psychotropic drugs is limited to the following factors: legal restrictions, the possibility of dependence, lack of prescription forms, the high cost of drugs.
- 3. The causes, according to doctors, which consumers are unable to purchase drugs, no drug at the pharmacy (25%), no prescription (30%), the high price of the drug (20%), lack of desire to be treated (17%) etc.
- 4. Violation of prescription drugs and improve self in Ukraine is one of the main problems of the health system.
