## THE MAIN FEATURES OF PHARMACEUTICAL EDUCATION ABROAD

A pharmacist is a specialist with a secondary or higher specialized education. Such a specialist should know the Technology of Drug Production, Pharmaceutical Chemistry, Pharmacology, Pharmacotherapy. The biggest drawback is the high cost of training, since this is associated with the spending of universities on the training of highly qualified specialists. The top 10 most prestigious universities where you can get a pharmacist diploma are Ulster University; Cardiff University; University of Bristol; University of Nottingham; Queen's University, Belfast; University of Manchester; Keele University; University of Leicester; University of East Anglia; University College London.

**Conclusions.** Finally, it may be concluded that the profession of a pharmacist is a highly paid specialty that requires enormous responsibility for people's health, a constant desire to improve their knowledge, acquire new skills in communicating with clients, and be able to simplify complex terms.
